Welcome



The M25 is one of the busiest and most important motorways in the UK. However, it is significantly under-served by places to rest, refresh, and refuel - especially across the eastern stretch for traffic feeding to and from the Channel ports.

Welcome Break is proposing to develop a new Motorway Service Area (MSA) to serve the busy eastern section of the M25 between junctions 27 (M11) and 28 (A12).

Our proposals respond to a need to reduce the existing distances on the M25 between MSAs. National policy states that the maximum distance between motorway services should be 28 miles and, in certain circumstances, 14 miles for HGVs.

The existing distances on the M25 exceed this, with a 33-mile gap between South Mimms and Thurrock as well as the forthcoming 62-mile gap between South Mimms and Maidstone that will occur once the new Lower Thames Crossing has been developed.

Consultation is an important part of our planning application process as it enables everyone to comment on the proposals with feedback helping inform the development of our proposals.



Why here?



The site comprises of 37.7 hectares of land either side of the M25. It is divided in two by the motorway with the larger space to the northeast (34.1 hectares) and the smaller space to the southwest (3.5 hectares) with a bridge connecting the two.

Adjoining the smaller space is a further 12.1 hectares of land owned by Welcome Break which is likely to remain outside the service area boundary but would instead be used to develop a biodiverse habitat that will improve the natural environment of the area.

This site sits perfectly between the South Mimms MSA and Thurrock MSA, reducing the 33-mile gap between stops as well as the forthcoming 62-mile gap between South Mimms and Maidstone that will occur once the new Lower Thames Crossing has been developed.

It will create green spaces for drivers to enjoy on their visit and provide new spaces and habitats for wildlife, with some 24% of the site committed to improving biodiversity.

Security and Traffic

- No vehicular access to or from local roads

Visibility

• The design incorporates reducing existing ground levels for the main developed areas and the introduction of earth mounds and extensive internal and peripheral woodland planting. This will break up the scale of the proposal and screen it from most external viewpoints.

Maintaining and contributing to your green space

 Our proposals will include a small diversion of an existing footpath around the edge of the services. Other footpaths running alongside the site boundary would be protected and new landscaping would be proposed to screen the scheme from walkers and create further green space and habitats.

Green spaces, net zero and biodiversity



Our proposals for Roding Valley have been developed with environmental stewardship and biodiversity in mind.

We have designed plenty of green spaces for drivers to enjoy on their visit and provide new spaces and habitats for wildlife:

 70% of the total site area will be green spaces including landscaping and areas for biodiversity net gain.

We have dedicated a separate area inside the M25 to the creation of a biodiverse habitat which will contribute to the Green Belt landscape:

 24% of the overall site area will be exclusively dedicated to biodiversity net gain, which will be located on around 12 hectares of land to the south of the site, inside the M25. To support the move to achieve net zero on carbon emissions, at the time of opening, the MSA will provide in excess of 50 rapid EV charging points, with well over 50 further EV ready charging points which can be deployed quickly as demand requires. The scheme has also been designed with a layout that can accommodate even more EV charging spaces in the future, again as demand requires.
